I grant this permission with full knowledge that I accept full responsibility for injury or accidents that may occur.

**3. INJURY TO PERSONS OR PROPERTY:** Responsible Party/Participant agrees that Whisper Mountain Ministries shall not be liable to Responsible Party or any other person for any injury occurring in, on, or around the Premises or at other locations. Responsible Party further agrees that Whisper Mountain Ministries shall not be liable for damages to Responsible Party’s property or to property of any third person which may be located in, on, or around the Premises or other locations.
